RESPONDENTS

164 people offered responses and ideas on the day

58 were in favour of developing the route – three said they were no strong opinion either way. No-one offered any criticism or was negative.

THEMES OF REPONSES AND IDEAS

Analysis of the material showed the following major themes that

Usage of existing and planned routes

There was concern that cyclists are not using the dedicated paths created to the west of Haverfordwest at the moment.

Despite development of paths (good paths already west of Haverfordwest)

- people still on roads rather paths need education on this
- Cyclists on roads would like to see more off road
- Enforce people to use cycle paths
- People on roads at the moment rather the built paths

Slebech is important as an opportunity and to avoid dangers of using the A40


- Slebech could benefit from visitors and offer food /drink etc
- Slebech stretch difficult needs to be used to avoid A40
- Business opportunity for Slebech!!
- Very nice tracks at Slebech already
- Not on the A40!! (x3)

Maintenance needed after build

- Maintenance an issue Areas already overgrown on paths developed to the west of HFW
- Maintenance on paths already developed overgrown
- Needs to be maintained
- Shared use a problem maintenance after building!

Accessibility and mixed usage

- Accessible for all
- Bluestone was gated/fenced off recently needs to be looked at
- Shared usage can cause issues
- Conflicts amongst users
- Difficult to access bridleways for riders from Johnston
- Horse and cyclists should be separated can cause damage to paths
- Speeding traffic an issue in places#
- Traffic bombs along straight roads



Nature of tracks

- Keep any tracks environmentally friendly raise awareness of wildlife and existing species. Place nature areas alongside or nearby?
- Don't use tarmac!
- Surfaces are important especially for multiuse for horses and bikes

Need to market the route and provide appropriate signage

- Important how the route is marketed
- Give an identity benches and sculptures
- Signage must be spot on for all users
- Signage needs to be improved "to avoid getting lost"

Haverfordwest-specific

- Need more in Haverfordwest to bring people in "Stop destroying the town" restaurants along the riverside?
- Ask holidaymakers would they come back to Haverfordwest?
- A bike park in the area would be good!
- Loops in and out of Haverfordwest "flower petals"
- Connect to Fortune Frolic in Haverfordwest
- Contact Mike's Bikes in Haverfordwest for involvement




Links with adequate public transport

Loops and Links to other trails, attractions and activities

- Links to Brunel Trail important (x2)
